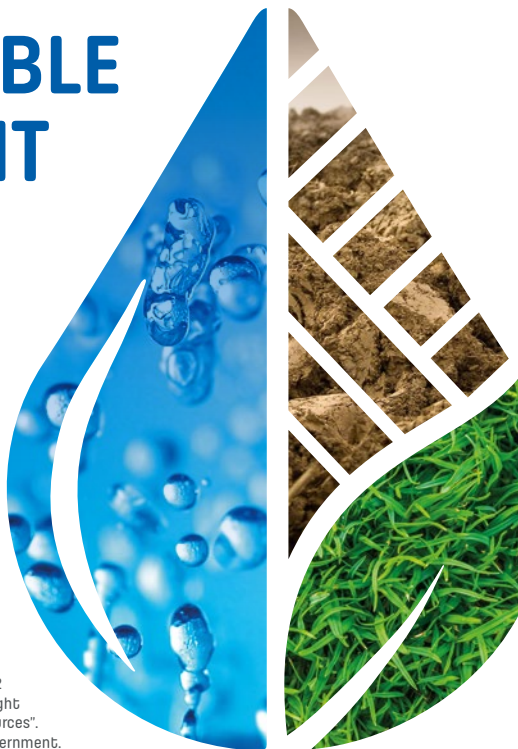

FOR RESPONSIBLE AND TRANSPARENT MANAGEMENT OF PUBLIC GOODS AND NATURAL RESOURCES

The project "For responsible and transparent management of public goods and natural resources" is carried out in partnership between the UDD – the Association for Democratic Society from Zagreb, Dobra Association from Metkovic and the Centre for Sustainable Development from Imotski in order to raise public awareness of the importance and benefits of responsible and transparent management of public goods and natural resources.

Within the project the editorial board has been established for the media coverage of the areas of public goods, the website javnodobro.udd.hr has been set up, seminars and workshops have been organized with the aim of strengthening journalists' capacities, the capacities of the representatives of civil society organizations and of the representatives of local and regional governments. Study trips to the areas of management of public goods for the representatives of partner organizations have also been organized, info centers for citizens have been established, and we have been carrying out an analysis of the implementation of Anti-corruption strategy from 2015 to 2020 and of the Strategy for development of public administration from 2014 to 2020. We are making educational materials and organizing info stands in the listed counties.

The project lasts from 10th November 2015 to 10th November 2017.
